Introduction

Background

This is the Department of Civil Service's tenth annual report, "New York State Government Employees' Workers' Compensation Claims." The report includes workers' compensation experience from five fiscal years (2012/2013 through 2016/2017).

Section 7 of the Civil Service Law was amended in *Chapter 171* of the Laws of 2007 (Appendix A of this report) to require that the President of the Civil Service Commission prepare an annual report describing occupational injuries, illnesses, and workers' compensation claims in Executive Branch state agencies. The report is required to be published by September 30th each year and includes workers' compensation data based on the last completed fiscal year. In subsequent years, the report shall include comparative data for up to five fiscal years. A similar report was published by the Department of Civil Service from 1986 through 1992.

The report format follows the sections specified in *Chapter 171* of the Laws of 2007, with the exception of Table 3 which consolidates subdivisions **(6d)** and **(6e)** of the legislation.

The Department of Civil Service's Employee Benefits Division is responsible for overseeing the workers' compensation policy between New York State and the New York State Insurance Fund (NYSIF). Part of this responsibility includes the reporting and monitoring of work-related incidents through the Accident Reporting System (ARS) and workers' compensation claims experience provided by NYSIF. Workers' compensation data for this report was obtained from both the ARS and NYSIF since neither source contains all of the statutorily-required data elements.

Incidents were reported up to June 30th of the reporting year with incident dates occurring during the fiscal year. A 15-month reporting period was used to capture more complete incident activity that occurred during the fiscal year. It should be noted that there are differences in the number of work-related incidents contained in the respective data reported from the ARS and NYSIF. There are incidents that are put into ARS and a corresponding claim is not created in the NYSIF system (e.g., due to no lost time or medical costs). Employee population data is obtained from the Department of Civil Service New York State Electronic Personnel System (NYSTEP).

Although this report presents only summarized data, New York State agency Human Resources and Health and Safety staff are encouraged to use the reporting capabilities of the ARS. The ARS allows for much greater detail of the information presented in this report, as well as many other workers' compensation incident details.

Explanatory Notes

The report *includes* selected Executive branch agencies' Classified Service employees, consistent with subdivision three of section two-a of the State Finance Law. The report *excludes* the Judicial and Legislative branches, as well as the Unclassified Service and Authorities, as the Department of Civil Service does not maintain employee data on these groups.

There were no agency closures, mergers or new agencies added during the reporting period.

Information in this report is based on New York State workers' compensation claims filed by employees. Although the reporting period is by Fiscal Years (FY) 2016/2017 (April 1, 2016, through March 31, 2017), FY 2015/2016 (April 1, 2015, through March 31, 2016), FY 2014/2015 (April 1, 2014, through March 31, 2015), FY 2013/2014 (April 1, 2013, through March 31, 2014), and FY 2012/2013 (April 1, 2012, through March 31, 2013), claims for fiscal years were reviewed until July 1st of the respective reporting years to allow for late reporting and for data to be captured for workers' compensation determinations made after the end of the fiscal year.

Incident data included in this report are for work-related incidents (either injuries or occupational illnesses) that were reported to the Workers' Compensation Board and the New York State Insurance Fund (NYSIF) as required by the New York State Workers' Compensation Law. The Law requires reporting of all incidents that result in either: one or more lost work days beyond the date of the incident; or, medical treatment beyond first aid or two or more first aid treatments. There are many incidents that do not reach the level of the reporting criteria under the Workers' Compensation Law.

As historically reported, this report includes certain statutory temporary disability workers' compensation costs incurred by Executive Branch employees and paid by the State Insurance Fund for one day up to 365 days' post-incident (based on the date the injury occurred within the fiscal year). For example, an accident that occurs on April 1 could have up to 365 days of compensation, whereas an accident that occurs on March 31 could have only one day of compensation reported. The report excludes all costs related to permanency awards, such as schedule loss of use awards, permanent partial and permanent total disability awards, and Section 32 settlements. The report also excludes all wages paid by NYS agencies while an employee is on workers' compensation leave, such as use of available leave credits, sick leave at half pay, all payments while an employee is on workers' compensation leave at full pay and workers' compensation supplemental pay.

Summary of Findings

Highlights are presented below for NYS Executive Branch agency workers' compensation incidents for classified employees incurred in FY 2012/2013 through FY 2016/2017.

- There were 13,271 work-related claims in FY 2016/2017 compared to 13,624 work-related claims in FY 2015/2016; 14,734 work-related claims in FY 2014/2015, 15,159 work-related claims in FY 2013/2014, and 14,598 work-related claims in FY 2012/2013. In addition, the overall workers' compensation incident rate decreased from 9.6% to 9.3% (Table 1, page 8).
- There were 4,109 lost-time incidents in FY 2016/2017, up from 3,986 in FY 2015/2016. Approximately 31.0% of workers' compensation incidents in FY 2016/2017 resulted in lost time (up from 29.3% in FY 2015/2016). (Table 2A, page 17).
- The lost-time incident rate for FY 2016/2017 increased to 2.9%. In FY 2016/2017, 265,393 work days were lost compared to 262,369 lost work days in FY 2015/2016 (Table 2B, page 26).
- *Total compensation costs and total medical costs decreased* from FY 2015/2016 to FY 2016/2017. Total compensation costs decreased by 2.0% from \$30,105,442 to \$29,509,456. Total medical costs decreased by 0.3% from \$25,977,143 to \$25,889,742 (Table 3, page 34).
- *Soreness, Pain, Hurt Excluding the Back* continues to be the category of incidents with the highest incident rate at 36.4% for FY 2016/2017, although down from 39.1% in FY 2015/2016. *Sprains, Strains, Tears* again ranked second with an incident rate of 20.4% for FY 2016/2017, up from 16.8% in FY 2015/2016 (Table 4A, page 44).
- The two leading incident causes in FY 2016/2017 were: *Bodily Reaction and Exertion* (but this incident decreased by 22.0% from 1,885 to 1,471) and *Fall to Floor, Walkway, or Other Surface* (which replaced *Bodily Reaction* as the second leading incident cause - increased by 9.0% from 823 to 897). *Patient Restraint* had the third highest incident rate in FY 2016/2017, increasing by 5.2% (from 809 to 851, Table 4B, page 48).
- The following were once again the reported top three body parts injured in all five fiscal years: *Knee(s)* (14.2% incident rate); *Shoulder, Including Clavicle, Scapula* (12.6% incident rate); and *Back, Including Spine, Spinal Cord* (7.6% incident rate) (Table 4C, page 51).
- The three job titles with the highest number of incidents were the same as reported in the past three Fiscal Years: *Correction Officer, Direct Support Assistant, and Mental Health Therapy Aide*. *Youth Division Aide 4* had the highest incident rate of 135.2% in FY 2016/2017, however, work-related incidents for this title decreased from 323 in FY 2015/2016 to 319 in FY 2016/2017. *Youth Division Aide 3* had the second highest incident rate at 68.0%, up from 55.4% in FY 2015/2016 (Table 5, page 54).

- The two agencies with 500 or more employees with the highest incident rates in FY 2016/2017 were *Marcy Correctional Facility* (incident rate of 37.5%) and *Mid-Hudson Psychiatric Center* (incident rate of 35.4%) (Table 6, page 58).
- In FY 2016/2017, *Security Services Unit Non-Arbitration* had the highest incident rate (34.5%), and *All Other Units and Unrepresented Group and Security Supervisors Unit Non-Arbitration* had the lowest incident rates (1.9%, respectively) (Table 7, Page 61). *Security Services Unit*, which had shown increases from FY 2012/2013 to FY 2015/2016, had the second highest incident rate of 20.8%, but this rate decreased from 21.0% in FY 2015/2016.

Table 1 lists the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivision (6a). The information in Table 1 was provided by the New York State Insurance Fund. The FY 2016/2017 claims experience includes accidents occurring between April 1, 2016, and March 31, 2017, and reported through June 30, 2017. The FY 2012/2013 through FY 2015/2016 claims experience is the same data reported in last year's report.

Agencies reported a total of 13,271 workers' compensation incidents and an incident rate of 9.3% in FY 2016/2017, a decrease from 13,624 incidents and an incident rate of 9.6% in FY 2015/2016. Previous years reported: 14,734 incidents and an incident rate of 10.4% in FY 2014/2015; 15,159 incidents and an incident rate of 10.6% in FY 2013/2014; and 14,598 incidents and an incident rate of 10.1% in FY 2012/2013.

Incident rates in the majority of the large agencies (3,000 employees or more) decreased. Rates of decrease in the following agencies ranged from under one percentage point to over one percentage point: the Department of Corrections and Community Supervision; the Education Department; and, the Department of Health. The largest decrease occurred in the Office of Mental Health (from 17.0% in FY 2015/2016 to 15.1% in FY 2016/2017). Incident rates increased in three large agencies: Department of Taxation and Finance; the Office of Children and Family Services; and, the Office of Parks, Recreation and Historic Preservation, where incident rates increased by as much as one percentage point.

Table 2A and **Table 2B** list the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivisions **(6b)**, and **(6c)**. The FY 2016/2017 claims experience includes accidents occurring between April 1, 2016, and March 31, 2017, and reported through June 30, 2017. The FY 2015/2016, FY 2014/2015, FY 2013/2014, and FY 2012/2013 claims experience is the same data reported in last year's report.

The number of lost-time incidents increased by 3.1% in FY 2016/2017 to 4,109, up from 3,986 in FY 2015/2016. The lost-time case rate (the number of Lost Time Incidents divided by the number of Incidents from Table 1) increased to 31.0% in FY 2016/2017, up from 29.3% in FY 2015/2016.

The lost-time rate (the number of Lost Time Incidents divided by the number of Full Time Equivalents) increased to 2.9% in FY 2016/2017 from 2.8% in FY 2015/2016. The number of lost work days increased by 1.2% in FY 2016/2017 to 265,393, up from 262,369 in FY 2015/2016.

Notably, lost work days decreased at the Department of Transportation by 13.6%, from 12,263 in FY 2015/2016 to 10,592 in FY 2016/2017. Lost work days also decreased at the Department of Parks, Recreation, and Historic Preservation by 9.2%, from 3,748 in FY 2015/2016 to 3,403 in FY 2016/2017. Lost work days decreased at the Office of Mental Health by 3.8%, from 54,633 in FY 2015/2016 to 52,534 in FY 2016/2017.

Conversely, lost work days increased at the Department of Corrections and Community Supervision by 9.6%, from 58,539 in FY 2015/2016 to 64,171 in FY 2016/2017, and at the Office for People with Developmental Disabilities by 6.0%, from 74,254 in FY 2015/2016 to 78,701 in FY 2016/2017.

Table 3 lists the selected Executive Branch New York State agencies and contains the workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivisions **(6d)** and **(6e)**. The claims experience in Table 3 was provided by the New York State Insurance Fund (NYSIF). The FY 2016/2017 claims experience includes incidents occurring between April 1, 2016, and March 31, 2017, and paid through June 30, 2017. The FY 2012/2013, FY 2013/2014, FY 2014/2015, and FY 2015/2016 claims experience is the same data reported in last year's report.

Under New York State Workers' Compensation Law, employees who are disabled due to a workers' compensation incident are entitled to a wage replacement for lost salary and medical benefits related to the incident. The wage component is equal to two-thirds of the employee's average weekly wage, not to exceed a maximum established under the Workers' Compensation Law. The statutory maximum for the past five years are as follows:

July 2012 – June 30, 2013: \$792.07
July 2013 – June 30, 2014: \$803.21
July 2014 – June 30, 2015: \$806.65
July 2015 – June 30, 2016: \$844.29
July 2016 – June 30, 2017: \$864.32

The data in Table 3 does not include supplemental wage replacement payment benefits as these amounts are paid by individual agencies and are not reflected in data maintained by the NYSIF. Under the medical component, all medical treatments – including doctor treatments, hospital or clinic charges, imaging services and diagnostic testing, prescription medication, and other related medical services – are paid in full based on a fee schedule established by the Chair of the Workers' Compensation Board, as directed by the Workers' Compensation Law.

All wage replacements and medical treatments are initially reviewed by the NYSIF. If there is a dispute between the NYSIF and the employee regarding such wage replacement or medical treatment, the Workers' Compensation Board will conduct a final review. Both the compensation costs and the medical costs are paid by the NYSIF under the provisions of the workers' compensation insurance policy between New York State and the NYSIF.

Total *compensation costs* decreased in FY 2016/2017 from \$30,105,442 to \$29,509,456; a decrease of 2.0%. Total *medical costs* decreased in FY 2016/2017 by 0.3%; from \$25,977,143 to \$25,899,742.

The most notable increase in both *compensation* and *medical costs* occurred at the Office for People with Developmental Disabilities, with *compensation costs* increasing by 10.4% or \$762,630 and *medical costs* increasing by 9.9% or \$464,161. Other notable changes occurred at the State University of New York (*compensation costs* increased by 8.2%), the Office of Mental Health (*medical costs* increased by 6.5%), and the Department of Corrections & Community Supervision (*compensation costs* decreased by 9.2% and *medical costs* decreased by 8.1%). Additionally, the Department of Health experienced a 46.6% decrease in total *compensation costs*, and 43.4% decrease in total *medical costs* from FY 2015/2016 to FY 2016/2017.

It should be noted that the compensation costs included in Table 3 only represent certain statutory temporary disability workers' compensation costs incurred by Executive Branch employees and paid by the State Insurance Fund for one day up to 365 days post-incident (based on the date the injury occurred within the year). For example, an accident that occurs on April 1 could

have to up 365 days of compensation whereas an accident that occurs on March 31 could have only one day of compensation reported. Table 3 excludes all costs related to permanency awards, such as schedule loss of use awards, permanent partial and permanent total disability awards, and Section 32 settlements. Table 3 also excludes all wages paid by NYS agencies while an employee is on workers' compensation leave, such as use of available leave credits, sick leave at half pay, all payments while an employee is on workers' compensation leave at full pay and workers' compensation supplemental pay.

In the next series of tables, details are provided on the most frequent types of injuries (Table 4A), incident causes (Table 4B), and body parts injured (Table 4C) as specified in *Chapter 171* of the Laws of 2007, subdivision (6f). The data in all three tables was derived from all incidents that resulted in a workers' compensation claim during FY 2012/2013 through FY 2016/2017.

The source of the data for most of the agencies is the Accident Reporting System (ARS). Incidents were reported up to June 30th of the reporting year with incident dates occurring during the fiscal year. A 15-month reporting period was used to capture more complete incident activity that occurred during the fiscal year. The number of incidents differ from those reported on Table 1 as the source of the information in this table is ARS and the source of Table 1 is NYSIF. There are incidents that are put into ARS and a corresponding claim is not created in the NYSIF system (e.g., due to no lost time or medical costs).

For the agencies using ARS, the *Occupational Injury and Illness Classification Manual* issued by the U.S. Department of Labor Bureau of Labor Statistics was used to capture the details on the types of injuries, accident causes, and body parts injured. This manual is the standard classification system used to classify occupational injuries and illnesses. Coding occupational injuries/illnesses is dependent upon the description provided by the individual reporting the incident, the classification system being used, and the codes selected by the individual entering the information. Certain categories may be viewed as similar, but they were reported separately in order to retain the integrity of the original reporting entity; for example, in Table 4B (page 47) *Falls; Fall to Floor, Walkway or Other Surface; Fall Down Stairs or Steps; and Fall on Same Level* were reported as separate categories.

Table 4A, the Most Frequent Types of Injuries, include injury types in which the inclusion criteria accounted for slightly over 98% of all incidents. Similar to the prior years, five injury type categories accounted for approximately three-fourths of all incidents in FY 2016/2017: *Soreness, Pain, Hurt, Excluding the Back* (36.4%); *Sprains, Strains, Tears* (20.4%); *Bruises, Contusions* (8.8%); *Back Pain, Hurt Back* (8.4%); and *Cuts, Abrasions, Bruises* (4.9%).

The Most Frequent Incident Causes are detailed in Table 4B. The five most frequent incident causes for FY 2016/2017 were *Bodily Reaction & Exertion* (9.5%); *Fall to Floor, Walkway, or Other Surface* (5.8%); *Patient Restraint* (5.5%); *Assault by Patient* (5.3%); and *Bodily Reaction* (5.3%). The greatest increases occurred in the following categories: *Fall Down Stairs or Steps* (increase of 1.6 percentage points); and, *Overexertion in Lifting* (increase of 1.4 percentage points). The greatest decreases occurred in the following categories:

Bodily Reaction & Exertion (decrease of 2.5 percentage points); and *Bodily Reaction* (decrease of 2.1 percentage points).

The Body Parts Most Frequently Injured are listed in Table 4C and account for approximately 99% of all incidents. In all five years, three body parts represented over one-third of the body parts injured: *Knee(s)* (14.2%); *Shoulder, Including Clavicle, Scapula* (12.6%); and *Back, Including Spine, Spinal Cord* (7.6%). An increase occurred in the *Knee(s)* category (increase of 0.5 percentage points). A decrease occurred in the *Back, Including Spine, Spinal Cord* category (decrease of 1.6 percentage points).

Table 5 contains the job titles with incident rates greater than 25% above the average for all employees in FY 2016/2017 as per *Chapter 171*, subdivision (**6g**). The average incident rate for all employees was 9.3% as reported in Table 1. The selected titles listed in Table 5 had an incident rate greater than 11.6% and a minimum of 50 FTEs to be included in the table.

Incident rates increased in several of the titles listed in Table 5. For the fourth year, *Youth Division Aide 4* had the highest incident rate of 135.2% in FY 2016/2017, up from 119.2% in FY 2015/2016. Over the five-year reporting period FY 2012/2013 to FY 2016/2017, the Incident Rate for this title has increased by 68.8 percentage points. *Youth Division Aide 3* had the second highest incident rate of 68.0%, up from 55.4% in FY 2015/2016. Over the five-year reporting period FY 2012/2013 to FY 2016/2017, the Incident Rate for this title has increased by 18.5 percentage points.

Incident rates decreased by 10 percentage points or greater from FY 2015/2016 to FY 2016/2017 in the following titles: *Security Hospital Treatment Assistant* (42.8 percentage points), *Security Hospital Senior Treatment Assistant* (29.3 percentage points), *Security Care Treatment Aide 1* (16.8 percentage points), *Bridge Repair Assistant* (16.1 percentage points), *Correction Officer Spanish Language* (15.6 percentage points), *Painter* (14.2 percentage points), and *Sign Crew Supervisor* (10.5 percentage points).

Subdivision (6h) of *Chapter 171* specifies that the Workers' Compensation Annual Report provide a list of State agencies with work-related injuries and illness rates that are more than 25% above the average incident rate for all State agencies. The average incident rate for all employees was 9.3% as reported in Table 1. The agencies listed in Table 6 had an incident rate greater than 11.6% in FY 2016/2017. The reader is referred to Table 1 for a listing of all State agencies and their respective incident rates.

Table 7 contains selected Executive Branch New York State negotiating units workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivision (6i). The information in Table 7 was provided by the NYSIF from the claims for the respective fiscal years.

The *Agency Police Services Unit* saw the largest incident rate increase of 1.6 percentage points (134 incidents in FY 2016/2017 versus 113 incidents in FY 2015/2016). The *Security Supervisors Non-Arbitration Unit* saw the largest incident rate decrease of 4.0 percentage points (1 work-related incident in FY 2016/2017 versus 3 work-related incidents in FY 2015/2016). The *Security Services Non-Arbitration Unit* saw the second largest incident rate decrease of 3.4 percentage points (605 work-related incidents in FY 2016/2017 versus 660 work-related incidents in FY 2015/2016). The *Security Supervisors Unit* saw the third largest incident rate decrease for work-related incidents of 3.3 percentage points (52 work-related incidents in FY 2016/2017 versus 67 work-related incidents in FY 2015/2016). The other employee groups had incident rates that were fairly stable.

Recommendations

The following recommendations regarding the prevention of injury and illnesses and the reduction of costs due to these cases were prepared in consultation with the Workers' Compensation Board (WCB) and the New York State Insurance Fund (NYSIF).

Accidents at work and occupational injuries represent a considerable economic burden for New York State employees and the State of New York. The NYSIF recommends a three-pronged approach for each New York State entity's Workers' Compensation Program. This includes Safety Management, Return to Work, and Fraud Prevention programs. Management commitment is essential for the implementation and on-going success of an agency's Workers' Compensation Program. Persons with the authority and responsibility for the safety management program must be identified and given management's full support.

- **Safety Management Program** – A Safety Management Program includes a comprehensive Injury and Illness Prevention Program along with defined Agency Safety Coordination to ensure accountability and implementation of the program. An effective Injury and Illness Prevention Program includes the following four elements: management commitment and employee involvement; worksite analysis; hazard prevention and control; and Injury and Illness prevention training. The NYSIF is available to agencies to provide advice and consultation on the implementation of a Safety Management Program including access to loss control resources, materials, education, etc. Visit the Employer tab at nysif.com and choose Injury and Illness Prevention for more information about workplace safety programs, and access to NYSIF's free Safety Resources.
- **Return to Work Program** – An active Return to Work Program is a key component in reducing cost by providing opportunities for injured workers to be productive while they recover from their injuries. The New York State Return to Work or Alternate Duty programs are governed by the collective bargaining agreements. The NYSIF and the Governor's Office of Employee Relations are a resource to the agencies to understand the terms and conditions of this program for the different negotiating units and how they relate to New York State's statutory obligation as an employer under the Workers' Compensation Law. The NYSIF is available to agencies to provide advice and consultation including access to resources, materials, education, etc. Agency Safety Coordination is essential to ensuring accountability and implementation of the agency's Return to Work Program. Agencies should continue to communicate with the injured worker to offer assistance and encouragement. Our mutual goal is a favorable medical outcome and a successful return to work.
- **Fraud Prevention Program** – Workers' Compensation Insurance fraud imposes a significant financial burden. An effective Fraud Prevention Program involves education and training, fraud and abuse detection, documentation, and reporting. The NYSIF is committed to training staff and investigating agency referrals of fraud and abuse.

The following are also recommended in an effort to prevent employees' Injuries and Illnesses:

- **System Improvements** – Through the ongoing WCB's Business Process Redesign project, the Board continues to work on several system improvements both technological and policy-oriented, that will improve timeliness and scheduling of required hearings (Virtual Hearings) and access to needed information at a hearing (eCase upload). The data from these new system improvements should be closely reviewed to identify trends and the need for further system enhancements.
- **Increase Awareness, Resources and Training** – It is well-established that the sooner an accident is reported and the sooner the injured worker obtains needed medical and temporary disability benefits, the better the outcome for all involved. New York State should ensure that workers' compensation awareness is a top priority in every State agency so that accidents are timely reported and injured workers receive timely care. Each agency, as assisted by the Governor's Office of Employee Relations and the Personnel Council, should provide training on workers' compensation policies so employees, managers, human resource officers, and payroll officers have a clear understanding of the resources available (including WCB's eCase), as well as the process and the requirements to receive the statutory and negotiated benefits, including supplemental pay, limited return to work, and dispute resolution programs. Each agency should set attainable goals on injury prevention and clearly define who and when to interact with injured employees and the NYSIF, as well as who is responsible for timely reporting of the First Report of Injury (FROI), changes in work status (Form C-11), wages paid while on workers' compensation leave (Form C-256.2), and PAYSERV transactions, in compliance with the Office of State Comptroller Payroll Bulletin 1366.
- **Data Sharing** – The eClaims initiative implemented in mid-2014 as well as recent improvements to the Board's data warehouse allow the possibility of flexible reporting of accident causes and locations, types of injuries, and temporary and permanent disability awards, by NYS agency/facility. The Department of Civil Service, WCB, and NYSIF should explore how to most effectively share this data with agencies to enable them to analyze the data, formulate corrective action plans, and enhance return to work programs.

CHAPTER 171

AN ACT to amend the civil service law, in relation to requiring annual reports about employee accident rates and costs in state agencies

Became a law July 3, 2007, with the approval of the Governor.
Passed by a majority vote, **three-fifths** being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 7 of the civil service law is amended by adding a new subdivision 6 to read as follows:

6. The president of the commission shall prepare an annual report describing occupational injuries, illnesses, and workers' compensation experience for all state agencies as defined by subdivision three of section two-a of the state finance law. Such report shall be published no later than September thirtieth of each year, beginning in two thousand eight, and shall report information on the basis of the last completed state fiscal year. In subsequent years, the report shall include comparative data for up to five prior fiscal years if such data is available. The report shall be delivered to the governor, the legislature and to any labor organization that represents state agency employees and shall be available to the public. The contents of the report shall include the following information for each state agency, broken down by institutions and facilities as was done in the report previously published by the department entitled "Occupational Accidents and Workers' Compensation Experience for NYS Government Employees" published from nineteen hundred eighty-seven to nineteen hundred ninety-two:

(a) the total number of employees, the number of work-related accidents and the rate of work-related injuries and illnesses;

(b) the number of lost work time injuries and illnesses and the rate of lost work time cases;

(c) the number of days of lost work time and the number and rate of lost full time employees;

(d) the cost to the state of lost work time due to work-related cases;

(e) the cost to the state of medical expenses due to work-related injuries and illnesses;

(f) a description of the types of injuries, the number of injuries and illnesses of each type and the most common causes of those cases, and the body part injured;

(g) a list of the job titles with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;

(h) a list of the state agencies with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;

(i) work-related injury and illness rates for all state agencies by collective bargaining units; and

EXPLANATION--Matter in italics is new; matter in brackets [-] is old law to be omitted.

(j) a summary of findings and recommendations prepared in consultation with the workers' compensation board and the state insurance fund for state agencies regarding the prevention of injury and illnesses and the reduction of costs due to these cases.

§ 2. This act shall take effect immediately.
