Introduction

Background

This is the Department of Civil Service's eleventh annual report, "New York State Government Employees' Workers' Compensation Claims." The report includes workers' compensation experience from five fiscal years (2013-2014 through 2017-2018).

Section 7 of the Civil Service Law was amended in *Chapter 171* of the Laws of 2007 (Appendix A of this report) to require that the President of the Civil Service Commission prepare an annual report describing occupational injuries, illnesses, and workers' compensation claims in Executive Branch state agencies. The report is required to be published by September 30th each year and includes workers' compensation data based on the last completed fiscal year. In subsequent years, the report shall include comparative data for up to five fiscal years.

The report format follows the sections specified in *Chapter 171* of the Laws of 2007, with the exception of Table 3 which consolidates subdivisions (6d) and (6e) of the legislation.

The Department of Civil Service's Employee Benefits Division is responsible for overseeing the workers' compensation policy between New York State and the New York State Insurance Fund (NYSIF). Part of this responsibility includes the reporting and monitoring of work-related incidents through the Accident Reporting System (ARS) and workers' compensation claims experience provided by NYSIF. Workers' compensation data for this report was obtained from both the ARS and NYSIF since neither source alone contains all the statutorily- required data elements.

Incidents were reported up to June 30th of the reporting year, with incident dates occurring during the fiscal year. A 15-month reporting period was used to capture more complete incident activity that occurred during the fiscal year. It should be noted that there are differences in the number of work-related incidents contained in the respective data reported from the ARS and NYSIF. There are incidents that are submitted to ARS, but a corresponding claim is not created in the NYSIF system (e.g., due to no lost time or medical costs). Employee population data is obtained from the Department of Civil Service New York State Electronic Personnel System (NYSTEP).

Although this report presents only summarized data, New York State agency Human Resources and Health and Safety staff are encouraged to use the reporting capabilities of the ARS. The ARS allows for much greater detail of the information presented in this report, as well as many other workers' compensation incident details.

Explanatory Notes

The report *includes* selected Executive branch agencies' Classified Service employees, consistent with subdivision three of section two-a of the State Finance Law. The report *excludes* the Judicial and Legislative branches, as well as the Unclassified Service and Authorities, as the Department of Civil Service does not maintain employee data on these groups.

There were no agency closures, mergers or new agencies added during the reporting period.

Information in this report is based on New York State workers' compensation claims filed by employees. Although the reporting period is for the Fiscal Years (FY) ending March 31, claims for fiscal years were reviewed through July 30th of the respective reporting years to allow for late reporting, and for data to be captured for workers' compensation determinations made after the end of the fiscal year.

Incident data included in this report are for work-related incidents (either injuries or occupational illnesses) that were reported to the Workers' Compensation Board and the New York State Insurance Fund (NYSIF) as required by the New York State Workers' Compensation Law. The Law requires reporting of all incidents that result in either: one or more lost work days beyond the date of the incident; or, medical treatment beyond first aid or two or more first aid treatments. There are many incidents that do not reach the level of the reporting criteria under the Workers' Compensation Law.

As historically reported, this report includes certain statutory temporary disability workers' compensation costs incurred by Executive Branch employees and paid by the State Insurance Fund for one day up to 365 days' post-incident (based on the date the injury occurred within the fiscal year). For example, an accident that occurs on April 1 could have up to 365 days of compensation, whereas an accident that occurs on March 31 could have only one day of compensation reported. The report excludes all costs related to permanency awards, such as schedule loss of use awards, permanent partial and permanent total disability awards, and Section 32 settlements. The report also excludes all wages paid by NYS agencies while an employee is on workers' compensation leave, such as use of available leave credits, sick leave at half pay, all payments while an employee is on workers' compensation leave at full pay and workers' compensation supplemental pay.

Summary of Findings

Highlights are presented below for NYS Executive Branch agency workers' compensation incidents for classified employees incurred in FY 2013-2014 through FY 2017-2018.

- There were 12,818 work-related claims in FY 2017-2018 compared to 13,271 work-related claims in FY 2016-2017; 13,624 work-related claims in FY 2015-2016, 14,734 work-related claims in FY 2014-2015, and 15,159 work-related claims in FY 2013-2014. In addition, the overall workers' compensation incident rate decreased from 9.3% to 9.0% (Table 1, page 8).
- There were 4,357 lost-time incidents in FY 2017-2018, up from 4,109 in FY 2016-2017. Approximately 34.0% of workers' compensation incidents in FY 2017-2018 resulted in lost time (up from 31.0% in FY 2016-2017) (Table 2A, page 18).
- The lost-time incident rate for FY 2017-2018 increased to 3.1%. In FY 2017-2018, 276,120 work days were lost compared to 265,393 lost work days in FY 2016/2017 (Table 2B, page 27).
- *While the total compensation costs increased, the total medical costs decreased* from FY 2016-2017 to FY 2017-2018. Total compensation costs increased by 9.0% from \$29,509,456 to \$32,162,214. Total medical costs decreased by 1.0% from \$25,889,742 to \$25,642,269 (Table 3, page 38).
- *Soreness, Pain, Hurt Excluding the Back* continues to be the category of incidents with the highest incident rate at 37.6% for FY 2017-2018, up from 36.4% in FY 2016-2017. *Sprains, Strains, Tears* again ranked second with an incident rate of 18.2% for FY 2017-2018, down from 20.4% in FY 2016-2017 (Table 4A, page 49).
- The two leading incident causes in FY 2017-2018 were: *Bodily Reaction and Exertion* (which increased by 18.3% from 1,471 to 1,740), and *Fall to Floor, Walkway, or Other Surface* (which increased by 23.2% from 897 to 1,105). *Patient Restraint* had the third highest incident rate in FY 2017-2018, increasing by 18.6% (from 851 to 1,009, Table 4B, page 51).
- The following were once again the reported top three body parts injured in all five fiscal years: *Knee(s)* (14.1% incident rate); *Shoulder, Including Clavicle, Scapula* (12.7% incident rate); and *Back, Including Spine, Spinal Cord* (7.4% incident rate) (Table 4C, page 54).
- The three job titles with the highest number of work-related incidents for the third consecutive year were: *Correction Officer, Direct Support Assistant, and Mental Health Therapy Aide*. *Youth Division Aide 4* had the highest incident rate of 102.1% in FY 2017-2018. However, work-related incidents for this title decreased from 319 in FY 2016-2017 to 238 in FY 2017-2018. Security Hospital Treatment Assistant had

the second highest incident rate: 95.2% in FY 2017-18 versus 62.4% in FY 2016-2017 (Table 5, page 58).

- The two facilities with 500 or more employees with the highest incident rates in FY 2017-2018 were the *Correctional Services Training Academy* (incident rate of 42.8%, down from 44.3% in FY 2016-2017) and *Marcy Correctional Facility* (incident rate of 40.2%, up from 37.5% in FY 2016-2017) (Table 6, page 62).
- In FY 2017-2018, *Security Services Unit Non-Arbitration* had the highest incident rate (32.2%), and *All Other Units and Unrepresented Group* had the lowest incident rate (0.9%) (Table 7, Page 65). The *Security Services Unit*, which experienced increases from FY 2013-2014 to FY 2015-2016, had the second highest incident rate of 20.8%, consistent with its rate in FY 2016-2017.

Table 1 lists the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivision (6a). The information in Table 1 was provided by the New York State Insurance Fund. The FY 2017-2018 claims experience includes accidents occurring between April 1, 2017, and March 31, 2018, and reported through June 30, 2018. The FY 2013-2014 through FY 2016-2017 claims experience is the same data reported in last year's report.

Agencies reported a total of 12,818 workers' compensation incidents and an incident rate of 9.0% in FY 2017-2018, a decrease from 13,271 incidents and an incident rate of 9.3% in FY 2016-2017. Previous years reported: 13,624 incidents and an incident rate of 9.6% in FY 2015-2016; 14,734 incidents and an incident rate of 10.4% in FY 2014-2015; and 15,159 incidents and an incident rate of 10.7% in FY 2013-2014.

Incident rates in the majority of the large agencies (3,000 employees or more) decreased. Rates of decrease in the following agencies ranged from under one percentage point to over one percentage point: Department of Taxation and Finance; State University at Stony Brook; the Office of Information Technology Services (Administration); and SUNY Upstate Medical Center. The largest decrease occurred in the Office of Children and Family Services (from 22.7% in FY 2016-2017 to 17.7% in FY 2017-2018). Incident rates increased in two large agencies: the Department of Environmental Conservation (from 4.3% in FY 2016-2017 to 4.4% in 2017-2018); and the Department of Health (Main Office) (from 1.1% in FY 2016-2017 to 1.3% in 2017-2018).

**Tables 2A and 2B: Workers' Compensation Lost Time
Selected New York State Agencies:
Fiscal Years 2013-2014 through 2017-2018**

Table 2A and **Table 2B** list the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivisions **(6b)**, and **(6c)**. The FY 2017-2018 claims experience includes accidents occurring between April 1, 2017, and March 31, 2018, and reported through June 30, 2018. The FY 2016-2017, FY 2015-2016, FY 2014-2015, and FY 2013-2014 claims experience is the same data reported in last year's report.

The number of lost-time incidents increased by 6.0% in FY 2017-2018 to 4,357, up from 4,109 in FY 2016-2017. The lost-time case rate (the number of Lost Time Incidents divided by the number of Incidents from Table 1) increased to 34.0% in FY 2017-2018, up from 31.0% in FY 2016-2017.

The lost-time rate (the number of Lost Time Incidents divided by the number of Full Time Equivalents) increased to 3.1% in FY 2017-2018 from 2.9% in FY 2016-2017. The number of lost work days increased by 4.0% in FY 2017-2018 to 276,120, up from 265,393 in FY 2016-2017.

Notably, lost work days increased at the Department of Transportation by 53.5%, from 10,592 in FY 2016-2017 to 16,254 in FY 2017-2018. Lost work days also increased at the Department of Corrections and Community Supervision by 27.7%, from 64,171 in FY 2016-2017 to 81,931 in FY 2017-2018.

Conversely, lost work days decreased at the Department of Parks, Recreation, and Historic Preservation by 9.3%, from 3,403 in FY 2016-2017 to 3,088 in FY 2017-2018. Lost work days also decreased at the Office of Mental Health by 4.9%, from 52,534 in FY 2016-2017 to 49,985 in FY 2017-2018.

**Table 3: Workers' Compensation Costs by

Table 3 lists the selected Executive Branch New York State agencies and contains the workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivisions (6d) and (6e). The claims experience in Table 3 was provided by the New York State Insurance Fund (NYSIF). The FY 2017-2018 claims experience includes incidents occurring between April 1, 2017, and March 31, 2018, and paid through June 30, 2018. The FY 2013-2014, FY 2014-2015, FY 2015-2016, and FY 2016-2017 claims experience is the same data reported in last year's report.

Under New York State Workers' Compensation Law, employees who are disabled due to a workers' compensation incident are entitled to a wage replacement for lost salary and medical benefits related to the incident. The wage component is equal to two-thirds of the employee's average weekly wage, not to exceed a maximum established under the Workers' Compensation Law. The statutory maximum for the past five years are as follows:

July 2013 – June 30, 2014	\$803.21
July 2014 – June 30, 2015	\$806.65
July 2015 – June 30, 2016	\$844.29
July 2016 – June 30, 2017	\$864.32
July 2017 – June 30, 2018	\$870.61

The data in Table 3 does not include supplemental wage replacement payment benefits as these amounts are paid by individual agencies and are not reflected in data maintained by the NYSIF. Under the medical component, all medical treatments – including doctor treatments, hospital or clinic charges, imaging services and diagnostic testing, prescription medication, and other related medical services – are paid in full based on a fee schedule established by the Chair of the Workers' Compensation Board, as directed by the Workers' Compensation Law.

All wage replacements and medical treatments are initially reviewed by the NYSIF. If there is a dispute between the NYSIF and the employee regarding such wage replacement or medical treatment, the Workers' Compensation Board will conduct a final review. Both the compensation costs and the medical costs are paid by the NYSIF under the provisions of the workers' compensation insurance policy between New York State and the NYSIF.

Total *compensation costs* increased in FY 2017-2018 from \$29,509,456 to \$32,162,214; an increase of 9.0%. Total *medical costs* decreased in FY 2017-2018 by 1.0%; from \$25,889,742 to \$25,642,269.

The most notable increase in both *compensation* and *medical costs* occurred at the Department of Transportation, with *compensation costs* increasing by 38.5% or \$499,392 and *medical costs* increasing by 40.2% or \$516,510. Other notable changes occurred at the Department of Corrections & Community Supervision (*compensation costs* increased by 33.7%

and *medical costs* increased by 6.9%), and the Department of Health (*compensation costs* increased by 19.9% and *medical costs* increased by 4.8%). Additionally, the State University of New York experienced a 13.2% decrease in *medical costs*, the Office of Mental Health experienced a 8.2% decrease in *medical costs*, and the Office for People with Developmental Disabilities experienced a 5.4% decrease in total *medical costs* from FY 2016-2017 to FY 2017-2018.

It should be noted that the compensation costs included in Table 3 only represent certain statutory temporary disability workers' compensation costs incurred by Executive Branch employees and paid by the State Insurance Fund for one day up to 365 days post-incident (based on the date the injury occurred within the year). For example, an accident that occurs on April 1 could have to up 365 days of compensation whereas an accident that occurs on March 31 could have only one day of compensation reported. Table 3 excludes all costs related to permanency awards, such as schedule loss of use awards, permanent partial and permanent total disability awards, and Section 32 settlements. Table 3 also excludes all wages paid by NYS agencies while an employee is on workers' compensation leave, such as use of available leave credits, sick leave at half pay, all payments while an employee is on workers' compensation leave at full pay and workers' compensation supplemental pay.

Tables 4A, 4B, 4C: Most Frequent Types of Injuries, Accident Causes, and Body Parts Injured: Fiscal Years 2013-2014 through 2017-2018

In the next series of tables, details are provided on the most frequent types of injuries (Table 4A), incident causes (Table 4B), and body parts injured (Table 4C) as specified in *Chapter 171* of the Laws of 2007, subdivision (6f). The data in all three tables was derived from all incidents that resulted in a workers' compensation claim during FY 2013-2014 through FY 2017-2018.

The source of the data for most of the agencies is the Accident Reporting System (ARS). Incidents were reported up to June 30th of the reporting year with incident dates occurring during the fiscal year. A 15-month reporting period was used to capture more complete incident activity that occurred during the fiscal year. The number of incidents differ from those reported on Table 1 as the source of the information in this table is ARS and the source of Table 1 is NYSIF. There are incidents that are put into ARS and a corresponding claim is not created in the NYSIF system (e.g., due to no lost time or medical costs).

For the agencies using ARS, the *Occupational Injury and Illness Classification Manual* issued by the U.S. Department of Labor Bureau of Labor Statistics was used to capture the details on the types of injuries, accident causes, and body parts injured. This manual is the standard classification system used to classify occupational injuries and illnesses. Coding occupational injuries/illnesses is dependent upon the description provided by the individual reporting the incident, the classification system being used, and the codes selected by the individual entering the information. Certain categories may be viewed as similar, but they were reported separately in order to retain the integrity of the original reporting entity; for example, in Table 4B (page 47) *Falls; Fall to Floor, Walkway or Other Surface; Fall Down Stairs or Steps*; and *Fall on Same Level* were reported as separate categories.

Table 4A, the Most Frequent Types of Injuries, include injury types in which the inclusion criteria accounted for slightly over 98% of all incidents. Similar to the prior years, five injury type categories accounted for approximately three-fourths of all incidents in FY 2017-2018: *Soreness, Pain, Hurt, Excluding the Back* (37.6%); *Sprains, Strains, Tears* (18.2%); *Bruises, Contusions* (9.0%); *Back Pain, Hurt Back* (8.3%); and *Cuts, Abrasions, Bruises* (4.8%).

The Most Frequent Incident Causes are detailed in Table 4B. The five most frequent incident causes for FY 2017-2018 were *Bodily Reaction & Exertion* (10.7%); *Fall to Floor, Walkway, or Other Surface* (6.8%); *Patient Restraint* (6.2%); *Bodily Reaction* (5.0%); and *Overexertion in Lifting* (4.9%). The greatest increases occurred in the following categories: *Bodily Reaction and Exertion* (increase of 1.2 percentage points); and, *Fall to Floor, Walkway, or Other Surface* (increase of 1.0 percentage points). The greatest decreases occurred in the following categories: *Fall Down Stairs or Steps* (decrease of 1.4 percentage points) and *Assault by Patient* (decrease of 1.0 percentage points).

The Body Parts Most Frequently Injured are listed in Table 4C and account for approximately 99% of all incidents. In all five years, three body parts represented over one-third of the body parts injured: *Knee(s)* (14.1%); *Shoulder, Including Clavicle, Scapula* (12.7%); and *Back, Including Spine, Spinal Cord* (7.4%). A decrease occurred in the *Knee(s)* category (decrease of 0.1 percentage points), and in the *Back, Including Spine, Spinal Cord* category (decrease of 0.2 percentage points). An increase occurred in the *Shoulder, Including Clavicle, Scapula* category (increase of 0.1 percentage points).

Table 5 contains the job titles with at least 50 FTEs with incident rates greater than 25% above the average for all employees in FY 2017-2018 as per *Chapter 171*, subdivision (6g). The average incident rate for all employees was 9.0% as reported in Table 1. The selected titles listed in Table 5 had an incident rate greater than 11.3% and a minimum of 50 FTEs to be included in the table.

Incident rates increased in several of the titles listed in Table 5. For the fifth year, *Youth Division Aide 4* had the highest incident rate of 102.1% in FY 2017-2018, down from 135.2% in FY 2016-2017. Over the five-year reporting period FY 2013-2014 to FY 2017-2018, the Incident Rate for this title has decreased by 11.1 percentage points. *Security Hospital Treatment Assistant* had the second highest incident rate of 95.2%, up from 62.4% in FY 2016-2017. Over the five-year reporting period FY 2013-2014 to FY 2017-2018, the Incident Rate for this title has increased by 7.1 percentage points.

Incident rates decreased by 10 percentage points or greater from FY 2016-2017 to FY 2017-2018 in the following titles: *Youth Division Aide 4* (33.1 percentage points), *Dev. Disability Secure Care Treatment Aide Tr.* (15.5 percentage points), *Dev. Disability Secure Care Treatment Aide 1* (15.3 percentage points), and *Dev. Disability Secure Care Treatment Aide 2* (10.7 percentage points).

The average incident rate for all employees was 9.0% as reported in Table 1. The agencies listed in Table 6 had an incident rate greater than 11.3% in FY 2017-2018. The reader is referred to Table 1 for a listing of all State agencies and their respective incident rates.

Table 7 contains selected Executive Branch New York State negotiating units' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivision (6i). The information in Table 7 was provided by the NYSIF from the claims for the respective fiscal years.

The negotiating units with the largest incident rate increases include:

- The Security Supervisors Unit (Non-Arbitration), which saw an increase of 5.9 percentage points (4 incidents in 2017-18 versus 1 incident in 2016-17); and
- The Operational Services Unit, which saw an increase of 0.4 percentage points (1,786 incidents in 2017-18 versus 1,719 incidents in 2016-17).

The negotiating units with the largest incident rate decreases include:

- The Institutional Services Unit, which saw a decrease from 4,490 incidents in 2016-17 to 4,109 incidents in 2017-18 – a decrease of 1.5 percentage points; and
- The Security Services Unit (Non-Arbitration), which saw a 2.3 percentage point decrease in work-related incidents – from 605 in 2016-17 to 568 in 2017-18.

Recommendations

The following recommendations regarding the prevention of injury and illnesses and the reduction of costs due to these cases were prepared in consultation with the Workers' Compensation Board (WCB) and the New York State Insurance Fund (NYSIF).

Accidents at work and occupational injuries represent a considerable economic burden for New York State employees and the State of New York. The NYSIF recommends a three-pronged approach for each New York State entity's Workers' Compensation Program. This includes Safety Management, Return to Work, and Fraud Prevention programs. Management commitment is essential for the implementation and on-going success of an agency's Workers' Compensation Program. Persons with the authority and responsibility for the safety management program must be identified and given management's full support.

- **Safety Management Program** – A Safety Management Program includes a comprehensive Injury and Illness Prevention Program along with defined Agency Safety Coordination to ensure accountability and implementation of the program. An effective Injury and Illness Prevention Program includes the following four elements: management commitment and employee involvement; worksite analysis; hazard prevention and control; and Injury and Illness prevention training. The NYSIF is available to agencies to provide advice and consultation on the implementation of a Safety Management Program including access to loss control resources, materials, education, etc. Visit the Employer tab at nysif.com and choose Injury and Illness Prevention for more information about workplace safety programs, and access to NYSIF's free Safety Resources.
- **Return to Work Program** – An active Return to Work Program is a key component in reducing cost by providing opportunities for injured workers to be productive while they recover from their injuries. The New York State Return to Work or Alternate Duty programs are governed by the collective bargaining agreements. The NYSIF and the Governor's Office of Employee Relations are a resource to the agencies to understand the terms and conditions of this program for the different negotiating units and how they relate to New York State's statutory obligation as an employer under the Workers' Compensation Law. The NYSIF is available to agencies to provide advice and consultation including access to resources, materials, education, etc. Agency Safety Coordination is essential to ensuring accountability and implementation of the agency's Return to Work Program. Agencies should continue to communicate with the injured worker to offer assistance and encouragement. Our mutual goal is a favorable medical outcome and a successful return to work.
- **Fraud Prevention Program** – Workers' Compensation Insurance fraud imposes a significant financial burden. An effective Fraud Prevention Program involves education and training, fraud and abuse detection, documentation, and reporting. The NYSIF is committed to training staff and investigating agency referrals of fraud and abuse.

The following are also recommended in an effort to prevent employees' Injuries and Illnesses:

- **System Improvements** – The Board continues to work on several system improvements as part of the ongoing WCB's Business Process Redesign project to improve stakeholder experience with the Board resulting in more timely, convenient and efficient resolutions. As of June 30, 2018, the Virtual Hearing pilot was implemented in 19 of the 26 districts, providing the opportunity for over 47,000 virtual hearings; approximately 40% of these hearings had one or more virtual attendees. By the end of 2018, the Board will also implement the eCase upload initiative to allow key documents needed for hearings to be uploaded and immediately viewable in the claimant's case folder; it is anticipated that this functionality will result in more timely resolutions (i.e., fewer continuations). Finally, the Board will also complete IT enhancements in early 2019 to allow authorized NYS agency human resource staff with automatic access to eCase, which is a repository for workers' compensation records, decisions and correspondence. The data from these new system improvements should be closely reviewed to identify trends and the need for further system enhancements.
- **Increase Awareness, Resources and Training** – It is well-established that the sooner an accident is reported and the sooner the injured worker obtains needed medical and temporary disability benefits, the better the outcome for all involved. New York State should ensure that workers' compensation awareness is a top priority in every State agency so that accidents are timely reported and injured workers receive timely care so that they may return to work as soon as possible. Staff at each agency should regularly receive training on workers' compensation policies so employees, managers, human resource officers, and payroll officers have a clear understanding of the resources available (including WCB's eCase), as well as the process and the requirements to receive the statutory and negotiated benefits, including supplemental pay, limited return to work, and dispute resolution programs. Each agency should set attainable goals on injury prevention and clearly define who and when to interact with injured employees and the NYSIF, as well as who is responsible for timely reporting of the First Report of Injury (FROI), changes in work status (Form C-11), wages paid while on workers' compensation leave (Form C-256.2), and PAYSERV transactions, in compliance with the Office of State Comptroller Payroll Bulletin 1366.
- **Data Sharing** – The eClaims initiative implemented in mid-2014 as well as recent improvements to the Board's data warehouse allow the possibility of flexible reporting of accident causes and locations, types of injuries, and temporary and permanent disability awards, by NYS agency/facility. The Department of Civil Service, WCB, and NYSIF should explore how to most effectively share this data, as well as NYSIF claims data, with agencies to enable them to analyze the data, formulate corrective action plans, and enhance return to work programs.

APPENDIX A

CHAPTER 171

AN ACT to amend the civil service law, in relation to requiring annual reports about employee accident rates and costs in state agencies

Became a law July 3, 2007, with the approval of the Governor.
Passed by a majority vote, three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 7 of the civil service law is amended by adding a new subdivision 6 to read as follows:

6. The president of the commission shall prepare an annual report describing occupational injuries, illnesses, and workers' compensation experience for all state agencies as defined by subdivision three of section two-a of the state finance law. Such report shall be published no later than September thirtieth of each year, beginning in two thousand eight, and shall report information on the basis of the last completed state fiscal year. In subsequent years, the report shall include comparative data for up to five prior fiscal years if such data is available. The report shall be delivered to the governor, the legislature and to any labor organization that represents state agency employees and shall be available to the public. The contents of the report shall include the following information for each state agency, broken down by institutions and facilities as was done in the report previously published by the department entitled "Occupational Accidents and Workers' Compensation Experience for NYS Government Employees" published from nineteen hundred eighty-seven to nineteen hundred ninety-two:

(a) the total number of employees, the number of work-related accidents and the rate of work-related injuries and illnesses;

(b) the number of lost work time injuries and illnesses and the rate of lost work time cases;

(c) the number of days of lost work time and the number and rate of lost full time employees;

(d) the cost to the state of lost work time due to work-related cases;

(e) the cost to the state of medical expenses due to work-related injuries and illnesses;

(f) a description of the types of injuries, the number of injuries and illnesses of each type and the most common causes of those cases, and the body part injured;

(g) a list of the job titles with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;

(h) a list of the state agencies with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;

(i) work-related injury and illness rates for all state agencies by collective bargaining units; and

(j) a summary of findings and recommendations prepared in consultation

with the workers' compensation board and the state insurance fund for state agencies regarding the prevention of injury and illnesses and the reduction of costs due to these causes.

§ 2. This act shall take effect immediately.
