Yes, the goal of 30 percent for MWBE participation applies to the entire contract value. The Offeror needs to provide an on- premise solution in the contiguous 48 states, on the ground. A cloud based solution is not permitted.

New York State and Participating Employer NYSHIP enrollees have the option to enroll in several fully insured HMO products. Under the provisions

				of this contract, the successful bidder will be required to maintain information provided by the Department about these enrollees but will not receive claims information from any HMO about these enrollees.

Page 7 requires offeror demonstrate that it meets the minimum requirement of five million (5,000,000) covered lives	The number of covered lives in the Empire Plan and NYSHIP may fluctuate; the numbers given are to illustrate current enrollment levels. The minimum requirement on page 7 to demonstrate coverage for 5,000,000 covered lives is separate to establish Offeror experience and capacity.
15	34	3.2(1)(c)(iv)	Can user training be administered using remote technology?	Section 5.5(3) of the RFP dictates onsite training. The Offeror must also state if Webinar training is available.
