Enclosed is the most recent revision (6/13/79) of the New York State Title and Salary Plan. PLEASE DESTROY ALL PREVIOUS EDITIONS OF THIS PLAN.

Part A of this plan lists alphabetically titles for all established positions in the classified service (competitive, noncompetitive, exempt, and labor classes). Part D lists titles for all unclassified service positions and titles for positions which were pending Budget Division approval at the time of this revision.

We call your attention to Part B of this plan which lists titles in the classified service in numeric sequence by title code. In particular note that those title codes beginning with the number 04 and 14 represent new functional groupings of titles. The 04 group new contains all professional accounting and auditing titles, while the 14 group new contains all public employee, personnel, manpower management, employee relations, training, staff development and affirmative action titles. The titles in both of these new groups had formerly been assigned other title codes. Because of the number of titles involved, no separate listing of the title code changes is being issued.

It continues to be extremely important that a copy of this plan be available to personnel and payroll staff. PLEASE BE SURE THAT THIS REVISED PLAN IS AVAILABLE TO THAT STAFF. If you need additional copies of the plan, we will send more while our supply lasts.
