6.1 **Suggestion No. 460561** - from the Department of Motor Vehicles (DMV) for Corey Truglia, a Grade 14 Supervising Motor Vehicle Representative 1 who proposed the issuance of temporary ten-day registrations. The purpose was to mitigate customer complaints that temporary registration renewals could only be obtained at a DMV field office. Mr. Truglia suggested that temporary registration requests should be expanded to the DMV call center and website. The suggestion committee for DMV reported the suggestion was implemented in May 2014, was not job related and amounted to a total net savings of \$39,938.72. The DMV's suggestion committee is recommending a tangible award of \$3,993.87 (10% of the first years savings) and a Certificate of Merit.
