Retroactive Adjustment

In addition to the April 1st rate change, a retroactive adjustment will be made to your health insurance premium later in the year to reflect the removal of the surcharge from the rates that you were charged between January 1, 2006 and March 31, 2007. This is a complex process that will take several months to complete. We will let you know as soon as possible how and when the retroactive adjustments will be made.

Important Information Regarding the Cost of Your Health Insurance Coverage

Beginning in January 2006, a surcharge was added to the premiums for coverage under the New York State Health Insurance Program (NYSHIP) to cover the cost of reimbursing Medicare Part B premiums to Medicare-eligible individuals. The surcharge was added to all NYSHIP premiums regardless of Medicare eligibility. The surcharge was challenged in court and a recent Appellate Court Division decision ordered the removal of the Medicare Part B surcharge from the 2006 and 2007 Empire Plan and HMO rates. As a result, 2007 NYSHIP premium rates will be revised effective April 1, 2007.

Although this action will result in a premium decrease for many enrollees, since you are enrolled in a NYSHIP HMO that costs more than The Empire Plan, your monthly cost will increase. This is because the employer's contribution for HMO coverage is no more than the amount contributed for Empire Plan coverage. Since the 2007 rates currently in effect included the Medicare surcharge, the premium for The Empire Plan was higher than it should have been. As a result, your former employer's share of the premium also was higher than it should have been for HMOs that cost more than The Empire Plan.

You can find the new rate applicable to your option and coverage on the enclosed chart. The chart represents your cost before the application of any sick leave credit to which you are entitled. If your sick leave credit is greater than your new rate, you will continue to have no premium contribution for 2007.

For enrollees that pay premiums through pension deduction, the new premium will be reflected in your pension check dated March 31, 2007, for April 2007 coverage. For enrollees that pay directly, this change will occur in your bill dated March 2, 2007, for April 2007 coverage.

Special Option Transfer Period through March 30, 2007

If your current premium is increasing effective April 1, 2007, you may change options as of April 1, 2007, even if it has been less than 12 months since you last changed options. We have included option transfer instructions and a copy of *Choices* with this letter. Your request to change options during this special option transfer period must be received by the Employee Benefits Division no later than March 30, 2007. After this, you will not be permitted to change options until 12 months pass since you last changed options (unless you have another qualifying event). This special option transfer period is only for enrollees who will have a premium increase.

YOU DO NOT HAVE TO DO ANYTHING IF YOU WISH TO REMAIN IN YOUR CURRENT HMO.
