SUBJECT: Guidelines for NYSHIP Participation at Health Fairs

DATE: April 28, 2008

Planning Your Health Fair

Are you planning a health fair this spring? Health fairs or employee information/wellness days are popular events for personnel offices to schedule, especially during the spring and fall. Many Employee Assistance Program (EAP) personnel and agency Health Benefits Administrators (HBAs) team up to sponsor these events.

To ensure appropriate use of NYSHIP resources and avoid scheduling conflicts, any participation in an agency health fair by NYSHIP health plans (The Empire Plan and NYSHIP HMOs) must be approved and coordinated through the Employee Benefits Division (EBD). When you plan your next health fair, please be sure to follow these simple steps.

- 1. Contact EBD's Communications Unit at 518-457-7577 as early as possible in the planning stage, or at least **four weeks prior** to the event.
- 2. To request an Empire Plan representative for your health fair, use the Employee Information Day/Health Fair Planning Information Form available on HBA Online. This is the quickest, most direct way to submit your request. From the home page, open Publications & Forms. Scroll down to Employee Information Day/Health Fair Planning Information Form and click on Display the Form. Contact the Help Desk at 518-457-5406 if you have problems with HBA Online access, or your processor, if you need general assistance. If you do not have access to HBA Online, use the attached hard copy version and fax it to the number listed.

Please do not contact The Empire Plan representatives directly.

The EBD Communications Unit will do this for you when your request is approved. Remember that Empire Plan representatives for health fairs typically do not give presentations or represent any other benefit programs such as the dental or vision programs or the long-term care (NYPERL) program. If you would like representatives from one or all of these programs to attend your health fair, call the Communications Unit at 518-457-7577 at least four weeks in advance of the date of the event to make your request.

- 3. If your health fair is approved by EBD, you may contact the NYSHIP Health Maintenance Organizations (HMOs) in your area to invite them to participate. See the attached list of NYSHIP Health Maintenance Organizations (HMOs) Contact Information for your planning.
- 4. We ask that you, as the agency Health Benefits Administrator, help coordinate and attend these events to answer general NYSHIP questions and support your employees.

To ensure NYSHIP participation, please follow these general guidelines for coordinating health fairs:

- NYSHIP policy does not permit participation in events organized or sponsored by for-profit entities such as event planners, even if there is no charge to NYSHIP participants.
- NYSHIP information is provided free of charge to State employees and we generally will not pay event admission fees or contribute to any baskets or raffles.
- Notify the EBD Communications Unit of any changes in date or location as soon as possible.
- If you are planning an outdoor health fair, be sure to designate an indoor location or alternate date in case of inclement weather.

Remember, if you allow for sufficient planning time, you stand the best chance of getting full participation of all NYSHIP health plans in your area.

Promoting Your Event

To optimize the use of NYSHIP resources, we ask that you do everything possible to maximize the number of enrollees who attend the health fair. Invite other agencies in your area to increase attendance. Display posters with the date, time and location of your health fair and advertise via email and interagency mail. Work closely with your EAP Coordinator and agency human resources personnel to promote your event.

Using Handouts and Giveaways

We will arrange for you to have handouts at your health fair that reflect the group designation(s) of your population, including our popular web site illustration for NYSHIP Online, an assortment of Empire Plan *Reporting Ons* and other publications with current health benefits information. In some cases we will also send Empire Plan giveaway items. If your attendee population has possible unique concerns or issues that may affect our selection of giveaways, please be sure to inform us of this ahead of time.

Please make these materials available to The Empire Plan representative at least one hour prior to the start time of the health fair. Leftover materials can be stored in your Personnel Office or, labels are provided to return them to our inventory.

After your health fair, we ask The Empire Plan representatives to submit feedback about it on an evaluation form (see attached). We use this information to gauge participation and the quantity of publications and giveaways we send, as well as to assist with evaluating future requests from State agencies. Promoting your health fair and bolstering your attendance will help ensure NYSHIP participation in future events.
