IMPORTANT NOTICE - PEP ENROLLMENT UPDATE FOR 2024

May 13, 2024

Dear DC-37 Enrollee:

As a result of the recently ratified contract between DC-37 and New York State, there will be a Productivity Enhancement Program (PEP) special enrollment period. PEP for 2024 allows eligible full- or part-time DC-37-represented employees to exchange previously accrued annual and/or personal leave in return for a credit to be applied toward the employee share of their NYSHIP premium on a biweekly basis. The program will be administered on a prorated basis effective July 1, 2024 through the end of the 2024 plan year.

There will be a special enrollment period during which:

- employees who are <u>eligible for but not currently enrolled in PEP</u> will be permitted to enroll in the program for the remainder of the 2024 plan year; and
- employees who are <u>currently enrolled in PEP</u> may choose between the following two scenarios:
 - take no action and maintain current PEP credit amounts for the remainder of the 2024 plan year; or
 - elect to forfeit additional annual and/or personal leave in exchange for increased PEP credit amounts for the remainder of the 2024 plan year

To initially enroll in PEP <u>or</u> to elect to forfeit additional previously accrued leave in exchange for increased PEP credit for the remainder of the 2024 plan year, **you must apply between May 28 and June 28, 2024**.

Details of the new program are shown in the table on the next page. Eligible part-time enrollees can participate on a prorated basis.
