## NYSHIP JULY 1, 2023 RATE CHANGES

For Retirees of Participating Employers

For retirees, vestees, dependent survivors and enrollees covered under Preferred List provisions of Participating Employers and their enrolled dependents



## Special Option Transfer Period (June 1–30, 2023)

The terms of a collective bargaining agreement between New York State and State employee unions have been administratively extended to retirees and vestees of Participating Employers and their enrolled dependents. This will result in NYSHIP rate changes effective July 1, 2023; the new rates included in this publication will be in effect through the end of 2023. As a result of these rate changes, there will be a Special Option Transfer Period during the month of June. The annual rate change for 2024 will occur on the first of the new year, as usual.

## How the Special Option Transfer Period Will Work

As a result of the rate changes, there will be a Special Option Transfer Period from **June 1 through June 30, 2023**. You may choose to change your plan option between The Empire Plan or a NYSHIPapproved Health Maintenance Organization (HMO) serving the area where you live.<sup>1</sup>

NO ACTION IS REQUIRED IF YOU WISH TO KEEP YOUR CURRENT HEALTH INSURANCE OPTION AND STILL QUALIFY FOR IT.

#### Summary of Benefits and Coverage

The Summary of Benefits and Coverage (SBC) is a standardized comparison document required by the Patient Protection and Affordable Care Act.

To view a copy of an updated *SBC* for The Empire Plan or a NYSHIP HMO, visit www.cs.ny.gov/sbc. If you do not have internet access, call 1-877-7-NYSHIP (1-877-769-7447) and select the Medical/Surgical Program to request a copy for The Empire Plan. If you need an *SBC* for a NYSHIP HMO, contact the HMO directly. PLEASE NOTE: A change during this Special Option Transfer Period will not be counted as an option change for the purpose of the once in a 12-month period limit for retirees. In addition, health insurance rates and benefit plan information for the 2024 plan year will be available at the end of the 2023 calendar year as they normally are and you will have the opportunity to review this material and change options again at that time, if you wish to do so. Online option changes using MyNYSHIP will NOT be permitted during the Special Option Transfer Period.

#### **Choices Explains Your Health Plan Options**

If you are considering changing your health insurance option or wish to review your current option, refer to *Health Insurance Choices for 2023*.<sup>2</sup> Refer to the May 2023 *Empire Plan Special Report* for information about the July 1, 2023 Empire Plan benefit changes. If you are an Empire Plan enrollee, you will receive this publication in the mail, or you can also access it on NYSHIP Online. Visit www.cs.ny.gov for this information or to generate a side-by-side comparison of the benefits provided by each of the NYSHIP plans in your area using the online NYSHIP Plan Comparison tool.

If you have questions about The Empire Plan, call toll free at 1-877-7-NYSHIP (1-877-769-7447). Select the Medical/Surgical Program and then the appropriate prompt for assistance with benefit questions. If you have questions about NYSHIPapproved HMOs, contact the HMOs directly (see pages 6 and 7). Be sure you understand how your benefits will be affected if you change plans. Changing plans may result in substantially different coverage and cost.

#### If You Decide to Change Your Option

The deduction for your new health insurance plan, plus or minus any retroactive adjustment needed, will be reflected in your pension check or monthly billing statement. **The date of the adjustment will depend on when your health insurance plan change is received and processed by the Employee Benefits Division (EBD).**

#### **Your Notice of Change Document**

If you receive your pension by direct deposit, your retirement system will notify you of any deduction changes. Your Notice of Change document will show new deduction amounts for your health plan's 2023 premium.

#### **Enrollees Who Pay the Employee Benefits Division Directly**

The new rate for your current health insurance plan for the remainder of the 2023 plan year will be reflected in your June bill for your July coverage. If you are changing options, the date of the adjustment will depend on when your change request is received and processed by the Employee Benefits Division.

#### Lifetime Sick Leave Credit

When you retired, you may have been entitled to convert your unused sick leave into a lifetime monthly credit that reduces your cost for health insurance for as long as you remain enrolled in NYSHIP. The amount of your monthly credit will remain the same throughout your lifetime. However, the balance you will pay for your health insurance premium may change each year. The most common reason for a change to the balance you pay would be a premium increase for your NYSHIP option for the new plan year. If your monthly credit is less than your health insurance premium, you pay the balance. When the retiree premium rises, the balance you must pay will also rise. To calculate the balance you will pay for the remainder of the calendar year 2023, subtract your monthly sick leave credit from the new monthly premium.

#### Keep Your Information Up to Date

It's important for you to keep EBD up to date with any changes to your enrollment record (address, adding or removing dependents, marital status changes) in a timely manner as deadlines may apply. Before sending a letter to EBD, be sure that it includes the last four digits of your Social Security number or your Empire Plan ID number, your permanent address and your phone number (including area code). The letter must also be signed and dated.
