

- MVP Health Plan, Inc. is approved to serve the Medicaid, Child Health Plus, Health and Recovery Plan (HARP) eligible populations in Albany, Columbia, Dutchess, Genesee, Greene, Jefferson, Lewis, Livingston, Monroe, Oneida, Ontario, Orange, Putnam, Rensselaer, Rockland, Saratoga, Schenectady, Sullivan, Ulster, Warren, Washington, and Westchester Counties. The provision of health care services in these counties is contingent upon the execution of the Medicaid and Child Health Plus contracts with New York State. The provision of HARP services in these counties is contingent upon execution of the Medicaid contract with New York State.

All aspects of operation in the Medicare only counties will be governed primarily by the Centers for Medicare and Medicaid Services (CMS), and implementation is contingent upon securing a Medicare contract with the Federal government.
