Introduction

Background

This is the Department of Civil Service's ninth annual report, "New York State Government Employees' Workers' Compensation Claims." The report includes workers' compensation experience from five fiscal years (2011/2012 through 2015/2016).

Section 7 of the Civil Service Law was amended in *Chapter 171* of the Laws of 2007 (Appendix A of this report) to require that the President of the Civil Service Commission prepare an annual report describing occupational injuries, illnesses, and workers' compensation claims in Executive Branch state agencies. The report is required to be published by September 30th each year and includes worker's compensation data based on the last completed fiscal year. In subsequent years, the report shall include comparative data for up to five fiscal years. A similar report was published by the Department of Civil Service from 1986 through 1992.

The report format follows the sections specified in *Chapter 171* of the Laws of 2007, with the exception of Table 3 which consolidates subdivisions **(6d)** and **(6e)** of the legislation.

The Department of Civil Service's Employee Benefits Division is responsible for overseeing the workers' compensation policy between New York State and the New York State Insurance Fund (NYSIF). Part of this responsibility includes the reporting and monitoring of work-related incidents through the Accident Reporting System (ARS) and workers' compensation claims experience provided by NYSIF. Workers' compensation data for this report was obtained from both the ARS and NYSIF since neither source contains all of the statutorily required data elements.

It should be noted that there are differences in the number of work-related incidents contained in the respective data reported from the ARS and NYSIF. The NYSIF database includes claims for employees not eligible for an ARS report as well as certain "small claims" (those with only one medical bill and no lost time), which may not be submitted through the ARS in all instances. Employee population data is obtained from the Department of Civil Service New York State Electronic Personnel System (NYSTEP).

Although this report presents only summarized data, New York State agency Human Resources and Health and Safety staff are encouraged to use the reporting capabilities of the ARS. The ARS allows for much greater detail of the information presented in this report, as well as many other workers' compensation incident details.

Explanatory Notes

The report *includes* selected Executive branch agencies' Classified Service employees, consistent with subdivision three of section two-a of the State Finance Law. The report *excludes* the Judicial and Legislative branches, as well as the Unclassified Service and Authorities, as the Department of Civil Service does not maintain employee data on these groups.

Information in this report is based on New York State workers' compensation claims filed by employees. Although the reporting period is by Fiscal Years (FY) 2015/2016 (April 1, 2015, through March 31, 2016), FY 2014/2015 (April 1, 2014, through March 31, 2015), FY 2013/2014 (April 1, 2013, through March 31, 2014), FY 2012/2013 (April 1, 2012, through March 31, 2013), and FY 2011/2012 (April 1, 2011, through March 31, 2012), claims for fiscal years were reviewed until July 1st of the respective reporting years to allow for late reporting and for data to be captured for workers' compensation determinations made after the end of the fiscal year.

Incident data included in this report are for work-related incidents, either injuries or occupational illnesses that were reported to the Workers' Compensation Board and the State Insurance Fund as required by the New York State Workers' Compensation Law. The Law requires reporting of all incidents that result in either: one or more lost work days beyond the date of the incident or medical treatment beyond first aid or two or more first aid treatments. There are many incidents that do not reach the level of the reporting criteria under the Workers' Compensation Law.

This report includes statutory workers' compensation costs incurred by Executive Branch employees covered under the policy with the New York State Insurance Fund. The reported compensation costs *do not include* enhanced benefits awarded through binding arbitration or negotiated through collective bargaining, specifically workers' compensation leave at full pay benefit and workers' compensation supplemental pay program.

Four Department of Correctional Services and Community Supervision facilities closed effective July 26, 2014: Monterey Shock (Schuyler Co.), Butler (Wayne Co.), Chateaugay (Franklin Co.), and Mt. McGregor (Saratoga Co.). There were no agency mergers or new agencies added during the reporting period.

Summary of Findings

Highlights are presented below for NYS Executive Branch agency workers' compensation incidents for classified employees incurred in FY 2011/2012 through FY 2015/2016.

- There were 13,624 work-related claims in FY 2015/2016 compared to 14,734 work-related claims in FY 2014/2015; 15,159 work-related claims in FY 2013/2014, 14,598 work-related claims in FY 2012/2013, and 15,136 work-related claims in FY 2011/2012. In addition, the overall workers' compensation incident rate decreased from 10.4% to 9.6% (Table 1, page 16).
- There were 3,986 lost-time incidents in FY 2015/2016. Approximately 29.3% of workers' compensation incidents in FY 2015/2016 resulted in lost time. The number of lost-time incidents decreased from 4,032 in FY 2014/2015. The lost-time case rate increased from 27.4% in FY 2014/2015 to 29.3% in FY 2015/2016. (Table 2A, page 26).
- The lost-time incident rate for FY 2015/2016 remained the same at 2.8%. In FY 2015/2016, 262,369 work days were lost compared to 271,765 lost work days in FY 2014/2015 (Table 2B, page 35).
- *Total compensation costs decreased while total medical costs increased* from FY 2014/2015 to FY 2015/2016. Total compensation costs decreased by 1.0% from \$30,412,575 to \$30,105,442. Total medical costs increased by 0.4% from \$25,869,811 to \$25,977,143 (Table 3, page 46).
- *Soreness, Pain, Hurt Excluding the Back* continues to be the category of incidents with the highest incident rate at 39.1% for FY 2015/2016, although down from 40.5% in FY 2014/2015. *Sprains, Strains, Tears* again ranked second with an incident rate of 16.8% for FY 2015/2016, down from 21.6% in FY 2014/2015 (Table 4A, page 48).
- The two leading incident causes in FY 2015/2016 were: *Bodily Reaction and Exertion* (which increased by 7.9% from 1,747 to 1,885) and *Bodily Reaction* (which increased by 12.4% from 1,034 to 1,162). *Fall to Floor, Walkway, or Other Surfaces* had the third highest incident rate in FY 2015/2016, but it decreased by 1.3 percentage points in FY 2015/2016 (Table 4B, page 50).
- The following were once again the reported top three body parts injured in all five fiscal years: *Knee(s)* (13.7% incident rate); *Shoulder, Including Clavicle, Scapula* (12.3% incident rate); and *Back, Including Spine, Spinal Cord* (9.2% incident rate) (Table 4C, page 54).
- The three job titles with the highest number of incidents were the same as reported in the past three Fiscal Years: *Correction Officer, Direct Support Assistant, and Mental Health Therapy Aide*. *Youth Division Aide 4* had the highest incident rate of 119.2% in FY 2015/2016. Work-related incidents for *Youth Division Aide 4* increased from 289 in FY 2014/2015 to 323 in FY 2015/2016. *Security Hospital Treatment Assistant* had the second highest incident rate at 105.2%, up from 97.3% in FY 2014/2015 (Table 5, page 58).

- The two agencies with 500 or more employees with the highest incident rates in FY 2015/2016 were *Mid-Hudson Psychiatric Center* (incident rate of 39.9%) and *Bedford Hills Correctional Facility* (incident rate of 38.1%) (Table 6, page 62).
- In FY 2015/2016, *Security Services Unit Non-Arbitration* had the highest incident rate (37.9%), and *All Other Units and Unrepresented Group* had the lowest incident rate (1.0%) (Table 7, Page 66). *Security Services Unit*, which has shown increases from FY 2011/2012 to FY 2015/2016, had the second highest incident rate of 21.0%.

Table 1 lists the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivision (6a). The information in Table 1 was provided by the New York State Insurance Fund. The FY 2015/2016 claims experience includes accidents occurring between April 1, 2015, and March 31, 2016, and reported through June 30, 2016. The FY 2011/2012 through FY 2014/2015 claims experience is the same data reported in last year's report.

Agencies reported a total of 13,624 workers' compensation incidents and an incident rate of 9.6% in FY 2015/2016, a decrease from 14,734 incidents and an incident rate of 10.4% in 2014/2015. Previous years reported: 15,159 incidents and an incident rate of 10.6% in FY 2013/2014; 14,598 incidents and an incident rate of 10.1% in FY 2012/2013; and 15,136 incidents and an incident rate of 10.4% in FY 2011/2012.

Incident rates in the majority of the large agencies (3,000 employees or more) decreased. Rates of decrease ranged from under one percentage point to over one percentage point, including the Office of Children and Family Services, Department of Taxation and Finance and Department of Environmental Conservation. The largest decrease occurred in the Office for People with Developmental Disabilities (from 17.1% in FY 2014/2015 to 14.1% in FY 2015/2016). Incident rates increased in three large agencies: the Department of Education, Office for Information Technology Services, and Office of Mental Health, where incident rates increased by less than one percentage point.

Table 2A and **Table 2B** list the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivisions **(6b)**, and **(6c)**. The 2015/2016 claims experience includes accidents occurring between April 1, 2015, and March 31, 2016, and reported through June 30, 2016. The FY 2014/2015, FY 2013/2014, FY 2012/2013, and FY 2011/2012 claims experience is the same data reported in last year's report.

The number of lost-time incidents decreased by 1.1 % in FY 2015/2016, consistent with the rate of decrease in number of incidents. However, the lost-time case rate increased to 29.3% in FY 2015/2016, up from 27.4% in FY 2014/2015. The lost-time rate remained at 2.8% in FY 2015/2016. The number of lost work days decreased by 3.5% in FY 2015/2016 to 262,369, down from 271,765 in FY 2014/2015.

Notably, lost work days decreased at the Department of Transportation by 19.2%, from 15,176 in FY 2014/2015 to 12,263 in FY 2015/2016. Lost work days also decreased at the Department of Health by 17.5%, from 5,100 in FY 2014/2015 to 4,209 in FY 2015/2016. Lost work days decreased at the Office for People with Developmental Disabilities by 17.2%, from 89,664 in FY 2014/2015 to 74,254 in FY 2015/2016.

Conversely, lost work days increased at the Office of Children and Family Services by 18.1%, from 18,091 in FY 2014/2015 to 21,374 in FY 2015/2016, and at the Office of Mental Health by 14.5%, from 47,726 in FY 2014/2015 to 54,633 in FY 2015/2016.

Table 3 lists the selected Executive Branch New York State agencies and contains the workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivisions **(6d)** and **(6e)**. The claims experience in Table 3 was provided by the New York State Insurance Fund (NYSIF). The FY 2015/2016 claims experience includes incidents occurring between April 1, 2015, and March 31, 2016, and paid through June 30, 2016. The FY 2011/2012, FY 2012/2013, FY 2013/2014, and FY 2014/2015 claims experience is the same data reported in last year's report.

Under New York State Workers' Compensation Law, employees who are disabled due to a workers' compensation incident are entitled to a wage replacement for lost salary and medical benefits related to the incident. The wage component is equal to two-thirds of the employee's average weekly wage, not to exceed a maximum established under the Workers' Compensation Law. The statutory maximum for the past five years are as follows:

July 2011 – June 30, 2012:	\$772.96
July 2012 – June 30, 2013:	\$792.07
July 2013 – June 30, 2014:	\$803.21
July 2014 – June 30, 2015:	\$806.65
July 2015 – June 30, 2016:	\$844.29

The data in Table 3 does not include supplemental wage replacement payment benefits as these amounts are paid by individual agencies and are not reflected in data maintained by the NYSIF. Under the medical component, all medical treatments – including doctor treatments, hospital or clinic charges, imaging services and diagnostic testing, prescription medication, and other related medical services – are paid in full based on a fee schedule established by the Chair of the Workers' Compensation Board, as directed by the Workers' Compensation Law.

All wage replacements and medical treatments are initially reviewed by the NYSIF. If there is a dispute between the NYSIF and the employee regarding such wage replacement or medical treatment, the Workers' Compensation Board will conduct a final review. Both the compensation costs and the medical costs are paid by the NYSIF under the provisions of the workers' compensation insurance policy between New York State and the NYSIF.

Total *compensation costs* decreased in FY 2015/2016 from \$30,412,575 to \$30,105,442; a decrease of 1.0%. Total *medical costs* increased in FY 2015/2016 by 0.4%; from \$25,869,811 to \$25,977,143. The largest increase in both *compensation and medical costs* occurred at the Department of Taxation & Finance, with *compensation costs* increasing by 71.4% or \$63,021 and *medical costs* increasing by 18.0% or \$19,310. Other notable increases or decreases occurred at the Office of Children and Family Services (*compensation costs* increased by 13.6%), the Office of Mental Health (*medical costs* increased by 15.1%), and the Department of Parks & Recreation (*compensation costs* decreased by 33.6% and *medical costs* decreased by 27.0%).

It should be noted that the compensation costs included in Table 3 only represent first-year payments associated with reportable accidents. First-year compensation costs are typically less than one-third of the total liability associated with an accident and exclude permanent disability awards, scheduled loss of use awards, and Section 32 settlements. Therefore, cost increases and decreases shown in Table 3 are not a complete financial representation of New York State Government employees' workers' compensation claims.

Tables 4A, 4B, 4C: Most Frequent Types of Injuries, Accident Causes, and Body Parts Injured: Fiscal Years 2011/2012 through 2015/2016

In the next series of tables, details are provided on the most frequent types of injuries (Table 4A), accident causes (Table 4B), and body parts injured (Table 4C) as specified in *Chapter 171* of the Laws of 2007, subdivision (6f). The data in all three tables was derived from the Accident Reporting System for all incidents that resulted in a workers' compensation claim during FY 2011/2012 through FY 2015/2016.

The *Occupational Injury and Illness Classification Manual* issued by the U.S. Department of Labor Bureau of Labor Statistics was used to capture the details on the types of injuries, accident causes, and body parts injured. This manual is the standard classification system used to classify occupational injuries and illnesses. Coding occupational injuries/illnesses is dependent upon the description provided by the individual reporting the incident, the classification system being used, and the codes selected by the individual entering the information. Certain categories may be viewed as similar, but they were reported separately in order to retain the integrity of the original reporting entity; for example, in Table 4B (page 50) *Falls; Fall to Floor, Walkway or Other Surface; Fall Down Stairs or Steps; and Fall on Same Level* were reported as separate categories.

Table 4A, the Most Frequent Types of Injuries, include injury types in which the inclusion criteria accounted for slightly over 98% of all incidents. Similar to the prior years, five injury type categories accounted for approximately three-fourths of all incidents in FY 2015/2016: *Soreness, Pain, Hurt, Excluding the Back* (39.1%); *Sprains, Strains, Tears* (16.8%); *Back Pain, Hurt Back* (9.1%); *Bruises, Contusions* (8.4%); and *Cuts, Abrasions, Bruises* (4.7%).

The Most Frequent Incident Causes are detailed in Table 4B. The five most frequent incident causes for FY 2015/2016 were *Bodily Reaction & Exertion* (12.0%); *Bodily Reaction* (7.4%); *Fall to Floor, Walkway, or Other Surface* (5.2%); *Patient Restraint* (5.2%); and *Assault by Patient* (5.1%). The greatest increases occurred in the following categories: *Assault by Patient* (increase of 1.3 percentage points), and *Bodily Reaction and Exertion* (increase of 0.9 percentage points). The greatest decreases occurred in the following categories: *Fall to Floor, Walkway, or Other Surface* (decrease of 1.3 percentage points); and *Falls* (decrease of 1.2 percentage points).

The Body Parts Most Frequently Injured are listed in Table 4C and account for slightly over 99% of all incidents. In all five years, three body parts represented over one-third of the body parts injured: *Knee(s)* (13.7%); *Shoulder, Including Clavicle, Scapula* (12.3%); and *Back, Including Spine, Spinal Cord* (9.2%). An increase occurred in the *Knee(s)* category (increase of 1.0 percentage points). A decrease occurred in the *Back, Including Spine, Spinal Cord* category (decrease of 4.6 percentage points).

Table 5 contains the job titles with incident rates greater than 25% above the average for all employees in FY 2015/2016 as per *Chapter 171*, subdivision (6g). The average incident rate for all employees was 9.6% as reported in Table 1. The selected titles listed in Table 5 had an incident rate greater than 12% and a minimum of 50 FTEs to be included in the table.

Incident rates increased in several of the titles listed in Table 5. For the third year, *Youth Division Aide 4* had the highest incident rate of 119.2% in FY 2015/2016, up from 102.5% in FY 2014/2015. Over the five-year reporting period FY 2011/2012 to FY 2015/2016, this title has shown a 48.4% increase. *Security Hospital Treatment Assistant* once again had the second highest incident rate of 105.2%, up from 97.3% in FY 2014/2015. Over the five-year reporting period FY 2011/2012 to FY 2015/2016, this title has shown a 28% increase.

Incident rates decreased by 10 percentage points or greater from FY 2014/2015 to FY 2015/2016 in the following titles: *Developmental Assistant Trainee* (15.9 percentage points), *Direct Support Assistant IRM* (12.8 percentage points), *Teaching Hospital Surgical Technologist 2* (11 percentage points), and *Direct Support Assistant Trainee* (10.5 percentage points).

Table 7 contains selected Executive Branch New York State negotiating units workers' compensation details specified in *Chapter 171* of the Laws of 2007, subdivision **(6i)**. The information in Table 7 was provided by the NYSIF from the claims for the respective fiscal years as detailed in the footnotes of the table.

The *Security Supervisors Unit* saw the largest percent increase in work-related incidents of 5.6% (67 incidents in FY 2015/2016 versus 40 incidents in FY 2014/2015). The *Security Supervisors Non-Arbitration Unit* saw the largest percent decrease in work-related incidents of 9.2% (three work-related incidents in FY 2015/2016 versus eight work-related incidents in FY 2014/2015). The *Institutional Services Unit* saw the second largest percent decrease in work-related incidents of 3.2% (4,540 work-related incidents in FY 2015/2016 versus 5,258 work-related incidents in FY 2014/2015). The other employee groups had incident rates that were fairly stable.

Recommendations

The following recommendations regarding the prevention of injury and illnesses and the reduction of costs due to these cases were prepared in consultation with the Workers' Compensation Board (WCB) and the New York State Insurance Fund (NYSIF).

Accidents at work and occupational injuries represent a considerable economic burden for New York State employees and the State of New York. The NYSIF recommends a three-pronged approach for each New York State entity's Workers' Compensation Program. This includes Safety Management, Return to Work, and Fraud Prevention programs. Management commitment is essential for the implementation and on-going success of an agency's Workers' Compensation Program. Persons with the authority and responsibility for the safety management program must be identified and given management's full support.

- **Safety Management Program** – A Safety Management Program includes a comprehensive Injury and Illness Prevention Program along with defined Agency Safety Coordination to ensure accountability and implementation of the program. An effective Injury and Illness Prevention Program includes the following four elements: management commitment and employee involvement; worksite analysis; hazard prevention and control; and Injury and Illness prevention training. The NYSIF is available to agencies to provide advice and consultation on the implementation of a Safety Management Program including access to loss control resources, materials, education, etc.
- **Return to Work Program** – An active Return to Work Program is a key component in reducing cost by providing opportunities for injured workers to be productive while they recover from their injuries. The New York State Return to Work or Alternate Duty programs are governed by the collective bargaining agreements. The NYSIF and the Governor's Office of Employee Relations are a resource to the agencies to understand the terms and conditions of this program for the different negotiating units and how they relate to New York State's statutory obligation as an employer under the Workers' Compensation Law. The NYSIF is available to agencies to provide advice and consultation including access to resources, materials, education, etc. Agency Safety Coordination is essential to ensuring accountability and implementation of the agency's Return to Work Program. Agencies should continue to communicate with the injured worker to offer assistance and encouragement. Our mutual goal is a favorable medical outcome and a successful return to work.
- **Fraud Prevention Program** – Workers' Compensation Insurance fraud imposes a significant financial burden. An effective Fraud Prevention Program involves education and training, fraud and abuse detection, documentation, and reporting. The NYSIF is committed to training staff and investigating agency referrals of fraud and abuse.

The following are also recommended in an effort to prevent employees' Injuries and Illnesses:

- **System Improvements** – The WCB's Business Process Redesign project continues to implement several proposals, both technological and policy-oriented, that will improve delivery of medical care (Medical Portal), timeliness and scheduling of required hearings (Virtual Hearings), and improve claimant access to their case records (Participant Portal). The data from these new system improvements will be closely reviewed by the WCB to identify trends and the need for further system enhancements.
- **Increase Awareness** – New York State should ensure that workers' compensation awareness is a top priority in every State agency. Each agency should clearly communicate and/or provide training on workers' compensation policies so employees, managers, human resource officers, and payroll officers have a clear understanding of the process and the requirements to receive the statutory and negotiated benefits, including supplemental pay, limited return to work, and dispute resolution programs. Each agency should set attainable goals on injury prevention and clearly define who and when to interact with injured employees and the NYSIF, as well as who is responsible for timely reporting of the First Report of Injury (FROI), changes in work status (Form C-11), wages paid while on workers' compensation leave (Form C-256.2), and PAYSERV transactions, in compliance with the Office of State Comptroller Payroll Bulletin 1366.
- **Data Sharing** – The eClaims initiative implemented in mid-2014 provides searchable data on accident causes and locations, types of injuries, and whether there was lost time. The Department of Civil Service, WCB, and NYSIF should explore how to most effectively share this data with agencies to enable them to analyze the data, formulate corrective action plans, and avoid accidents.
- **Functional Impairment Data** – With the adoption of the 2012 Impairment Guidelines by the WCB, employers are required to provide appropriate detail about the physical job requirements of the at-injury job to determine if the injured worker is capable of performing the at-injury job. This information is crucial for timely return to work and the proper classification of permanent partial disabilities. State agency personnel familiar with the injured employee's work activities should be encouraged to complete the NYSIF's Employee Job Functional Exertion Analysis, on or after eight weeks of lost time to describe the claimant's at-injury job and the functional capabilities needed to perform the job.
- **Timely Repair of Equipment** – At a number of facilities, common injuries appear to be the result of faulty equipment. Agencies should make proper and timely repairs to promote worker safety.
- **Workplace Violence Prevention Plans** - Some injuries on the job are related to workplace violence. State agencies are required by law to develop and implement Workplace Violence Prevention Programs that cover all employees at each agency worksite. Statewide mandatory workplace violence training was rolled out and completed by all employees in 2014. Each agency's workplace violence prevention program should be reviewed and updated at least annually and should be done in tandem with an analysis of the workers' compensation claims data.

CHAPTER 171

AN ACT to amend the civil service law, in relation to requiring annual reports about employee accident rates and costs in state agencies

Became a law July 3, 2007, with the approval of the Governor.
Passed by a majority vote, three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 7 of the civil service law is amended by adding a new subdivision 6 to read as follows:

6. The president of the commission shall prepare an annual report describing occupational injuries, illnesses, and workers' compensation experience for all state agencies as defined by subdivision three of section two-a of the state finance law. Such report shall be published no later than September thirtieth of each year, beginning in two thousand eight, and shall report information on the basis of the last completed state fiscal year. In subsequent years, the report shall include comparative data for up to five prior fiscal years if such data is available. The report shall be delivered to the governor, the legislature and to any labor organization that represents state agency employees and shall be available to the public. The contents of the report shall include the following information for each state agency, broken down by institutions and facilities as was done in the report previously published by the department entitled "Occupational Accidents and Workers' Compensation Experience for NYS Government Employees" published from nineteen hundred eighty-seven to nineteen hundred ninety-two:

- (a) the total number of employees, the number of work-related accidents and the rate of work-related injuries and illnesses;
- (b) the number of lost work time injuries and illnesses and the rate of lost work time cases;
- (c) the number of days of lost work time and the number and rate of lost full time employees;
- (d) the cost to the state of lost work time due to work-related cases;
- (e) the cost to the state of medical expenses due to work-related injuries and illnesses;
- (f) a description of the types of injuries, the number of injuries and illnesses of each type and the most common causes of those cases, and the body part injured;
- (g) a list of the job titles with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;
- (h) a list of the state agencies with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;
- (i) work-related injury and illness rates for all state agencies by collective bargaining units; and

(j) a summary of findings and recommendations prepared in consultation with the workers' compensation board and the state insurance fund for state agencies regarding the prevention of injury and illnesses and the reduction of costs due to these cases.

§ 2. This act shall take effect immediately.
