## Department of Civil Service Announces New Career Opportunities for Engineers in New York State

New Examination Program Provides Continuous Access to Job Opportunities for Engineers

More than 250 Engineering Positions Anticipated Statewide Over Next Six

Months

The Department of Civil Service today announced the New York State Career Opportunities in Engineering Program, a new civil service exam program that will provide qualified engineers with immediate and continuous access to a wide array of job opportunities across state government. More than 250 engineering positions are expected to be filled statewide over the next six months.

The new exam series offers candidates the opportunity to apply and complete an online questionnaire that will be used by more than 20 state agencies, as candidates are needed to fill engineering vacancies across the state.

"The New York State Career Opportunities in Engineering Program provides a great opportunity to connect the next generation of leaders in various engineering fields with careers across New York State government. Through this program, New York State will continue its efforts to build a pipeline of new, diverse talent and create an extensive talent pool for state agencies," said **Lola W. Brabham, Acting Commissioner of the Department of Civil Service.**" I encourage all qualified candidates to apply for the Engineering exams and pursue a rewarding and meaningful career with the State of New York."

Engineering careers are available to college graduates in engineering and engineering technology, individuals who have passed the National Council of Examiners for Engineering and Surveying (NCEES) Fundamentals of Engineering (FE) exam, and New York State licensed and currently registered Professional Engineers. Applications for the exam are accepted continuously and there is no application fee or application deadline. New York State employs more than 2,000 engineers in various agencies across the state.

Candidates may apply for the following engineering titles in New York State based on their qualifications and experience. To learn more about the engineering specialties, including minimum qualifications for each engineer title, view the below examination announcements.

Each engineering title has specialized engineering fields, from civil to environmental engineering, that require specific engineering experience, education, certification, or licensure.

Candidates can apply by selecting the level of engineer, specialized engineer area, and the state agency for which they are interested in employment. Information provided in the online questionnaire will then be used to review candidate qualifications and will serve as the test for these titles.

State agencies will score online questionnaires periodically throughout the year when additional qualified candidates are needed to fill vacancies. Once added to the list of eligible candidates, individuals will have a two-year period of eligibility for appointment.
