SUMMARY OF REVISIONS OR NEW MATERIAL

- Updating 0800 Table of Contents to replace Special Salary Treatments with Salary Differentials.
- Updating 0830 Definition of Terms to remove “Appointing Officer Application” as it is no longer relevant; updated “Decentralized Agencies,” “Decentralized Titles,” “Pass Through,” “Post-Audit Review,” “Pre-Audit Review,” “Reviewable Record,” “Short Form Transaction,” and “Title and Salary Plan” definitions to reflect updates to C&C’s decentralized classification program. Also, we replaced Special Salary Treatments with Salary Differentials.
- Updating 0840 Title and Salary Plan Elements to reflect current negotiating unit names (APSU) and job levels (removed “temporary”); decentralization status to reflect updates to C&C’s decentralized classification program; to replace Advisory Memorandum with C&C Update; and replace Special Salary Treatments with Salary Differentials.
- Updating 0850 B- Classification Processing Requirements to remove reference to Short Form transactions as only 131.1a requests are submitted via a short form; added proposed minimum qualifications as a requirement for 64.3 positions; and updated an obsolete hyperlink.
- Updating 0850 D- State Negotiating Units to reflect current negotiating unit names (APSU) and removed obsolete titles.
- Updating 0860 Decentralization to replace Special Salary Treatments with Salary Differentials.
- Updating 0870 Special Salary Treatments; 0870 A- 130.4; 0870 B-130.6; 0870 C-130.7; and 0870 E-130.13 to replace Special Salary Treatments with Salary Differentials.
- Updating 0870 F-131.1a to replace Special Salary Treatments with Salary Differentials; to clarify our policy regarding same geographic area or location; and to remove reference to the pre-approved 131.1a listing that is no longer maintained.
